objective not a problem statement. The (specific) objectives have been reduced to two(2) but the findings still have three sections, the last one being Impact of Agricture Sector Development which is not covered by these two objectives stated. The write up on method used in collecting data, last paragraph of Materials and Method, need to be edited in terms of English as to make the meaning clearer. The survey method (not survey result) is used to collect data in both Jayapura and Keerom? That is using the questionnaire? That is stated for Keerom but not for Jayapura.

A very well written paper based on the descriptive analysis of the research and able to make a reader follows what the researcher would like to share. The ideas and descriptions are coherent and clear. However, there is a pertinent matter that should be considered to make this paper more comprehensible. Please state your objectives of the study/paper with clarity. You can insert this/these on the introduction since this part has highlighted the background of the paper

The methodology is not clear. it is not stated what form of a survey had been conducted i,e the method used to choose samplings, size of samples, the analysis used for the data collected. It is noticeable that most of the quantitative data described in this paper are referred from other studies. If this is so, then please inform or write that the empirical data used is based on secondary materials.

Overall the study shows a variety of information and data from other sources, thus making this research very interesting to compare findings from other studies. However, if it has been stated earlier that the analysis of the data is based on the quantitative findings of this research, apart from literature reviews, the writer must be able to discuss the quantitative findings too.
